## About... Membership

---

Each municipality in Palm Beach County may be a member of the Palm Beach County League of Cities. Dues are established by the Board of Directors, based on population & ad valorem valuation formulas.

## Associate Membership

---

Individuals, nonprofit organizations, Special Districts and business entities which support or serve municipalities are eligible. Associate Members, sponsored by a municipal member, submit application and payment to the League office with final approval going to the Board of Directors. The League welcomes participation in its committees, activities and general membership meetings by Associates, however they are nonvoting members.

## Ex Officio Members

---

Ex-Officio Memberships are composed of governmental agencies, upon the nomination of such agency by any municipal member, and approval by the Board of Directors.

## Our Meetings

---

Our Board of Directors and General Membership luncheons meet the 4th Wednesdays of the month except May and December. Meetings are at various host locations around the county. Directors may propose items of business by notifying the Executive Director who shall place such items on the agenda.

## Our Board of Directors

---

18 city officials serve on our Board: 4 executive officers, one representative from each of the 5 League districts, six representatives from the largest municipalities (population over 25,000), two at-large seats and the immediate past president. Any past president(s) still holding elected office may serve ex-officio (nonvoting).

## The Officers

---

During the March/April Membership meetings, elections are held to select officials to be installed for the offices of President, 1st Vice President, 2nd Vice President, Secretary-Treasurer, and the Board.

## The Executive Director

---

The Board appoints an Executive Director, who serves at the pleasure of the Board. The Executive Director is responsible

for the daily operation of the business of the League. The Executive Director serves as chief liaison to the County Commission, School Board, department staff, the Legislature & Congressional Delegation on behalf of the Palm Beach County League of Cities.

The League is also represented on state, regional & county committees and boards.
